We share only the information reasonably necessary and expect our partners to treat it responsibly.

Confidentiality of Ministry Communications

Personal, spiritual, and ministry-related communications are treated with care and discretion. Information is shared only when necessary to fulfill your request, provide ministry assistance, comply with applicable law, protect individuals, or with your permission.

SMS Communications

If you opt in, WJI may send informational SMS messages regarding ministry inquiries, prayer request follow-up, events, ministry communications, ministry partner coordination, and other requested communications.

Message frequency varies.

SMS consent is not shared with third parties or affiliates for marketing purposes.

World Jesus Institute does not sell, rent, or trade your personal information. Information may be shared only with trusted ministry partners, service providers (including website hosting, email, SMS, cloud storage, and payment processing), when required by law, to protect legal rights or safety, or with your permission.

Our website may use cookies and similar technologies to improve functionality, remember preferences, analyze website traffic, and enhance the visitor experience. You may disable cookies through your browser settings.

Donations

If you make a donation, payment information is processed through trusted third-party payment processors. World Jesus Institute does not store complete payment card information.
